Teachers ensure that only parents are able to access Class Dojo groups and consistently monitor groups for safety.

In 2023, Bass Hill Public School will continue to use Class Dojo to share information regarding student learning and whole school organization and events.

To ensure that your child's teacher can establish a Dojo account for your child, parents must complete the permission slip below. This gives permission for your child's information to be shared with the App.

The Class Dojo database uses the same HTTPS security connections banks and government departments use to store and transfer data. To date, Class Dojo has not experienced a data breach.
